SIDEWALK CAFÉ OPERATOR'S AGREEMENT

Initial each box, complete the bottom and return with your application

- I understand that I may not operate a sidewalk café unless I have received a permit certificate and that the certificate shall be posted on the establishment so that it is visible from the street.

- I understand that the sidewalk café may not encroach upon the public area of the sidewalk in a manner that will reduce the clear pedestrian way beyond the level set in the Village Code.

- I understand that objects may not be permanently affixed to the sidewalk and that I may not alter or damage the sidewalk in any manner.

- I understand that the hours of operation for the sidewalk café are 8 a.m. until 11 p.m. each night.

- I understand that no additional signage or advertising material may be incorporated into the sidewalk café. This includes portable signs, and screening materials used in the design of the sidewalk café.

- I understand that the sidewalk café area must be kept clean at all times. To this end, wait staff shall serve all patrons and bus tables as needed.

- I understand and agree that no outdoor cooking shall be permitted at any time and that the preparation and service of flaming foods shall be conducted in accordance with the New York State Fire Code §308.6.

- I understand that live entertainment is not permitted at the sidewalk café. I also understand that all recorded music shall cease playing by 10 p.m. each evening.

I understand and agree to all of the above. In the event that there is a violation of the code in respect to these rules, I agree to be held liable for the same.
